- 2. Not to engage in any fundraising or other activity using Epilepsy NZ's name, logo or other image unless you have received approval in writing by Epilepsy NZ to do so;
- 3. That you are not permitted to make any representations on Epilepsy NZ's behalf, nor bind Epilepsy NZ to any arrangement or contract;
- 4. To deposit all funds raised within 7 days of the completion of the fundraising event using the bank details provided to you by Epilepsy NZ;
